Steps for Creating Quality Genetics

Jerry Gustin walks us through the latest Miller Gustin Angus feed trials.

We began feed trials for our yearling bulls on June 2. The first weights were taken at 28 days. Overall the bulls did quite well with an average weight per day gain of 4.76 pounds. A Baldridge Waylon sired bull came in with a 6.29 pounds per day average. For a sire group, two Fortress calves made the top five with one at 5.71 pounds and another at 5.57 pounds. Health problems so far have been minimal with a few bulls requiring pinkeye treatment. Both Craig and I experienced a little higher incidences of ring worm this year, but we are happy to note that that it has pretty well subsided. Jeff Tyson, our nutritionist, went through the bulls and is pleased with the gain and the overall condition of the bulls and

recommended no adjustments to the ration. As you will note from a review of the sheet (page 2), we have a large group of industry-leading sires represented. The KCF Bennett Absolute calves appear to be the standouts so far, but they are closely trailed by the GAR 100 X and KCF Bennet Fortress sons.

All the experts tell us we need to focus on herd health, nutrition, management and genetics. We have been working hard to improve our program in all these areas. These initial weight reports tell us that we are making solid progress. As an example, when we compare our growth EPDs to Angus average, we come out over 13 pounds above for weaning and almost 24 pounds over average for

yearling. In fact, we are well above average in almost all traits of economic importance. Pounds are still the common denominator for most cattle sales. These bulls are beginning to demonstrate solid performance for us and they will do the same for your program.

Oh by the way, we are increasing our female offerings this year. Many of the females

we are selling will be full ET sibs to these bulls. They will make excellent replacements in any herd, and a couple of them may be donor cow quality. We will be providing listings of these females on our website (millergustinangus.com) and in future newsletters once we make final sale selections.

Miller Gustin Supports Wildfire Relief

Miller Gustin Angus stepped up to support farmers and ranchers affected by destructive wildfires in Kansas, Oklahoma, Texas and Colorado. The recent fires swept through an estimated 1.5 million acres, killed seven people and destroyed homes, cattle and livelihoods.

In the Shenandoah Valley, Craig & Nancy Miller organized a chicken BBQ on April 29 at their local West Rockingham Park. Pilgrim's Pride and Cargill Turkey Productions donated 650 halves of chicken; Red Front Super Market pitched in supplies, and Doug Shank & Dale Knicley donated charcoal. The Millers, who are very active in their community, were generously supported by neighbors, Ruritan members and fellow farmers in their efforts and generated over \$7,900 to support the wildfire relief effort.

At the east end of the state, Jerry Gustin worked with his fellow Farm Bureau Board Members to make a series of donations. The first donation totaled \$1,300 from the Gloucester Matthews Farm Bureau and local cattlemen. As more details of the magnitude of the disaster became available, the Board authorized an additional \$5,000 contribution that was eligible for a matching grant from the Howard G. Buffet/Progressive Farmer Foundation, essentially doubling the amount donated.

In total, the Miller Gustin team made an impact of over \$19,000 toward wildfire relief efforts.
